Subject: Report on unlawful assembly, promoting enmity between different groups on ground of religion and race, uttering words etc with deliberate intent to wound the religious feelings of any person, Attempt to murder, Theft in dwelling house etc, Robbery, Dacoity, Mischief, House breaking/trespass and Criminal intimidation committed and other unlawful activities by the unruly goons of Meitei/Meitei Community.

Sir/Madam,

I have the honor to state the following few facts for your kind perusal and necessary legal action.

That, on the 4th May, 2023 at around 2-3:00 PM, a Government Quarter allotted in my name i.e. allotted in the name of T. Chinkhotuan Paite, Department: DIPR, Govt. of Manipur, Designation : Reporter at Quarter Type- III/C-10 situated in Lamphelpat, P.O. & P.S. Lamphel, Imphal West, Manipur, some miscreants and unruly goons belonging to the Meitei/Meitei Community coming from the main road towards my resident Quarter by chanting a slogan like "Kangleipak na yay pha re" and "Hao Hatlo" with a deadly weapons like sharp iron rod, Sword, Dow, Knife, Sticks and Automatic Rifles has attacked, vandalized and torched our resident Quarter. They even robbed and steal the remnants thereby bringing disgraceful to the prevailing humanity a mankind has pursued ever and anon.

That, these Meitei/Meitei unruly goons broke open my/our gate(s), robbed, looted, vandalized, destroyed and torched all valuable movable/immovable property(s) and other valuable documents including Electronic Furniture and Household items from my/our resident Quarter and premises worth around Rupees 10,00000-(Approx.). It may be pertinent to mentioned here that I/we are left with nothing as I/we had to run for my/our life with a narrow escape from our back door. I am presently taking shelter at Dorcas Veng, New Lamka, Churachandpur.

Now, therefore, with outmost respect, I request your good office to take strong actions against the perpetrators by registering an FIR under the relevant provision of law (to mention some relevant sections are Sec. 143, 153A, 153B, 298, 307, 379, 392, 395, 397, 436, 440, 449, 450 and 506 of Indian Penal Code), investigate the matter at the earliest and booked the culprit(s) according to the law of the land.
