That, on the 4<sup>rd</sup> May,2023 at around 10:00 AM, while I am staying peacefully with my family at Government Quarter allotted in the name of my son namely Shri Ngamminlun Lhungdim, a government employee working at 7th Manipur Rifle, bearing Rifleman No. 072006109, situated at Langol Type III Quarter No. H.14, some miscreants and unruly goons belonging to the Meitei/Meetei Community coming from the main road towards my dwelling house by chanting a slogan like "Kangleipak na yay pha re" and "Hao Hatlo" with a deadly weapons like sharp iron rod, Sword, Dow, Knife, Sticks and Automatic Rifles has attacked and vandalized our dwelling place. They even robbed and steal the remnants thereby bringing disgraceful to the prevailing humanity a mankind has pursued ever and anon.
