I may be allow to bring to your kind attention that on the 04.05.2023 at
around 10-11 PM , **my residence** (which is a Government Quarter allotted to my
Husband namely Shri Mangkhochoh Touthang, serving as 1st IRB, Rifleman No.
0920001301, under the Home Department, Govt. of Manipur) located at National
Game Village, Zone-I, Qrt. No. D/73, Imphal West, Manipur, was **attacked,**
destroyed and looted by groups of goons belonging to Meitei/Meetei
community.

These Meitei criminals/goons broke open my gate(s), destroyed and looted
every valuable property including domestic animals (pigs) from my residence and
premises worth around Rupees 10 Lakhs (Approx.). It may be pertinent to
mentioned here that the looting and ransacking is still going on till today.

Now, therefore, with outmost respect, I request your good office to take
strong actions against the perpetrators by registering an FIR under relevant
sections of the Indian Penal Code, investigate the matter at the earliest and booked
the culprit(s) according to the law of the land.
