Sir.

With due respect, I have the honour to report the following few lines that, I am one of the sellers cum driver of AAA traders company located at Nongmeibung. That on today i.e the 12<sup>th</sup> December, 2023, I along with my local younger brother namely Md. Samir aged about 18 years S/o Md. Jalalluddin of Khomidok Umang Leikai went to Kanglatongbi Bazar for dispatch our company goods items i.e Juices, Coca-Cola, sprite, Fanta, thumps up, Maza etc by driving our company vehicle i.e Tata Dicor bearing registration number MN03W/1477 and collected a sum of Rs. 75,240/- (Rupees Seventy Five Thousand two hundred fourty) only from different shops of Kanglatongbi Bazar for selling the goods items. However on the same day i.e the 12<sup>th</sup> December, 2023 at around 02:30 pm, while returning home after dispatching the goods items, our vehicle was forcefully stopped at Khonghampat Chingol along NH-2 near Apapi Hotel by unknown armed persons wearing black mask & dresses numbering about 6 persons who are coming with two vehicles i.e one Bolero red in colour and one Maruti 800 car steel in colour without registration number. In that, the unknown armed persons forcefully looted/robbed the said amount i.e Rs 75,240/- (Rupees Seventy Five Thousand two hundred forty) only and two mobile phone i.e VIVO having mobile No. 9863173849 and MI Note 4 having mobile No. 6009914831 from us and they fled away from the spot towards Sekmai along NH-2.

It is, therefore, requested you to kindly take up necessary legal action.
