Subject - Report on attempt to murder / crimes on vandalism, looting and burning of properties / discrimination of Scheduled Tribes (KUKI/ZO).

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the ^{Yuar}.....Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989. That, I am to bring to your notice that on the 3rd May, 2023 at around 4:00 a.m./p.m. My residence located at ^{Lamphel}.....
^{Lamphel} Housing Complex Hill, P.O./P.S. ^{Lamphel}....., District- ^{Imphal}.....
was attacked, destroyed, looted and burnt by a Group of Meeitei/Meiteis radicals suspected to be members of Arambai Tengol and Meitei Leepun.

These criminals broke open my gate(s), destroyed and looted every valuable property from my House, and premises worth Rupees ^{70,000} (Rupees ^{Seventy lakhs forty thousand}.) Only (Approx.).

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

Therefore, with utmost Respect I request you to take strong actions against the perpetrators by registering an FIR/ZERO under the relevant sections of Law.
