Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of  
**National Games Village Zone-IV, Qtr. No. B/18, Imphal West, Manipur.**

That, on the **4<sup>th</sup> May, 2023** specific time unknown my above residence, a Government allotted quarter was looted and ransacked by a Group of Meetei/Meitei radicals.

As I had left my residence with my family on the above said day and could not take any of my belongings. These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence and premises worth Rupees ₹ 52,20,000 (Approx.)

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an **FIR/Zero FIR** under relevant sections of Law.
