Subject: Request for registering FIR regarding theft/burglary of household properties

Madam,

*Sir*

With reference to the subject mentioned above I have the honour to report to you the following matter for your kind information and necessary action.

That I, Shri H Kham Minthang Age about 39 years S/o H. Shinkhokam, resident of Phualva Street, Dorcas Road, New Lamka- 795006, am an employee in the office of the Principal Accountant General (Audit) Manipur, Imphal. I was an occupant of quarter no. Type-II/03 at AG Staff Colony, Lamphelpat, Imphal West until the morning of 4 May 2023, when we abandoned the stated quarter and left behind all our belongings, and has not returned since owing to the ongoing ethnic violence and law and order failure in the State.

With the violence ongoing and its end nowhere in sight, I surrendered the stated quarter on 17 August 2023, and entrusted all my belongings to the care and custody of my neighbour Shri Onesimus Ngashangva, occupant of Type-II/04.

That, upon enquiry on 9 Sept 2023, I was informed that my official Acer laptop issued by my office along with my personal 2TB external hard drive was nowhere to be found. Also, an unused and packaged Vguard geyser (10 Litre new condition) was not traceable. It was highly suspected that this was apparently an incident of theft/burglary by unknown miscreants, where the time of incidence could not be ascertained (between the date of our departure on 4 May 2023 till 8 Sept 2023). Other household belongings missing/lost/stolen items are yet to be determined.

In the light of the above reported incidences, I humbly request you to kindly register an FIR/ZERO FIR regarding theft/burglary of the above stated items, investigate the matter and identify and punish the perpetrators as per the prevailing provisions of the law of this country.

I am willing to cooperate fully during the investigation.
