

That, I am a Scheduled Tribe belonging to the Zou Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential-quarter located at Qtr. No. C-69, Zone-I, National Game Village, P.O./.P.S.-Lamphelpat, District-Imphal West-795004, taking refuged at Central Reserved Police Force (CRPF), Lamphel, it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 3rd of May,2023 at around 9:00 PM.

That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.20,08,900/-(Rupees Twenty Lakhs Eight Thousand Nine Hundred) only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
