

Sir,

With reference to the subject mentioned above I have the honour to report to you as follows: -

- 1. That I, Shri. Blesso Thienminlun Haokip Age about 30 years S/o Lamkhohoi Haokip, belonging to the Thadou-Kuki Tribe/Community, a Schedule Tribe recognised under the constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.
- That, I was allotted Type-B12 quarter at CPWD GPRA colony at Sangaiprou, Imphal West, Manipur vide No.9(47)/MCD-I/2019-20/783 dt. 25/09/2019. Due to the ongoing crisis in Manipur, I had to flee from my quarter on 4th May, 2023 leaving behind all my properties, including important official and academic documents.
- 3. That, on August 26th, 2023, an incident occured at my official residence in Sangaiprou, Imphal quarter Type-B/12 . The Junior Engineer of CPWD, while inspecting my quarter after my request alerted me, that my residential quarter had been ransacked and all properties were looted or destroyed by unknown miscreants. This heinous act resulted in significant damage and loss to me and my family. (Details enclosed as Annexure-I).

4. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge financial loss which may be estimated to about Rs 4,31,510 (Rupees Four Lakh Thirtyone Thousand Five Hundred and ten) only.

5. I also would like to mention that I am filing this information late due to the trauma and mental pressure I faced which in turns affect my health. Now that I am in better health condition, I am filing this report today.

In view of the above circumstances, I humbly request you to kindly register an FIR/ZERO FIR, investigate the matter and identify and punish the perpetrators as per the prevailing provisions of the law of this country. With sincere anticipation, I shall be highly obliged.

I am willing to cooperate fully during the investigation.
