Sir.

In submitting herewith the enquiry report in c/w the above cited reference, I have the honour to state that on 22/09/2023, the complainant Shri R.K Athoiba @ VIP (24) R.K Ratan of UripokYambemLeikai, Imphal-West District, Manipur lodged acomplaint reportto the Officer-In-Charge Lamphel Police Station stating that on 18/09/2023 in between 01:00 pm to 03:00 pm an accident was occurred near Home Guard office, Shija Road between one two wheeler Yamaha FZ (Black in colour), bearing Regd. No.Nil ridden by RK. Chitarajan, one Tata Magic four wheeler (Red) bearing Regd. No. not known ridden by an unknown person, both coming from Lamphel side towards Shija Hospital and one four wheeler Santro Zing (Silver in colour), bearing Regd. No. not known coming from opposite direction from Shija Hospital side towards Lamphel driven by an unknown rider. Due to rash and negligence driving on the part of the unknown four wheeler Tata Magic driver, the two wheeler Yamaha FZ rider namely RK. Chitarajan received severe injury on his chest and other parts of his body. The unknown four wheeler Santro Zing car's rider picked up R.K Chitaranjani.e injured rider of two wheeler and rush to Shija Hospital for medical treatment but now shifted to RIMS Hospital. In that accident the two wheeler Yamaha FZ was partly damaged.

Therefore, he requested to kindly acknowledge and take action against the rider of Tata Magic vehicle.

Accordingly, I have enquired into the matter on being endorsed to me by OC-LPS under G.D Enter No.30/LPS/2023 dated 26/09/2023 and submitted the enquiry report before Officer-in-Charge of Lamphel Police Station for taking up necessary action.

That, during the course of enquiry, visited at the spot but no skid mark of the vehicles could be collected from the spot as the complaint was reported to OC-LPS on 22/09/2023 & the accident was occurred on 18/09/2023. Examined some PWs (i) KhundrakpamBoicha Singh (35) S/o (Late) Kh. Ibomcha Singh of KhangabokAwangLeikai a/p at the rented house of one ShriTombalocated at Lamphel Super Market & (ii) PebamAshni Kumar (29) S/o P. Basanta of KongpalKshetriLeikai a/p SoibamLeikai near JNIMS Main gate including the complainant very minutely and tactfully in c/w the case. On examination they all fully corroborated and supported the OE of the case.

PWs (i) ShriKhundrakpamBoicha Singh stated thatit was drizzling on the day when the accident took place i.eon 18/09/2023. On the same dayShriPebamAshni Kumar was driving one Honda Activa and he was sitting behind ShriPebamAshni Kumar and when they were on the way coming from NIT towards Lamphel to buy spare parts for i20 car, he saw the two wheeler FZ bike mention in the complaint report coming from opposite direction i.e from Lamphel side towards NIT collided lightly with one four wheeler Santro Xing car which was coming just behind their Honda Activa Scooter. The unknown biker fell down on the road and the Tata Magic vehicle (mention in the complaint report) which was coming just behind the FZ bike ran over the driver's body

and fled away. He got down from the Activa scooter and stopped a Scooter coming on the way and after hiring the same scooter he started chasing the aforesaid Tata Magic vehicle till Shija Hospital crossing. He got down from the scooter & tried to slap the Tata Magic vehicle driver but the auto driver and other Tata Magic drivers present there intervened & forced him to go back. He further added that if he sees the driver of the Tata Magic, he will recognize him.

PW (ii) ShriPebamAshni Kumar also supported the statement given by ShriKhundrakpamBoicha Singh and further stated that with the help of the unknown rider of theSantro Xing car, the victim was rushed to Shija hospital for medical treatment by putting the victim in his car.

That, particulars/details of all the 3(three) vehicles which were involved in c/w present case have been obtained. The particulars/details of the 3 (Three) vehicles are as follows:

- 1. Tata Magic (Red), bearing Regd. No.MN04A-3330.
- 2. Hyundai Santro Xing (Silver), bearing Regd. No.MN06LB-6106.
- 3. Yamaha FZ (Black), bearing Regd. No.NIL.

In the course of enquiry, there is an evident of committing a cognizable offence and henceappropriate decision which is deemed fit may be taken from your end.
