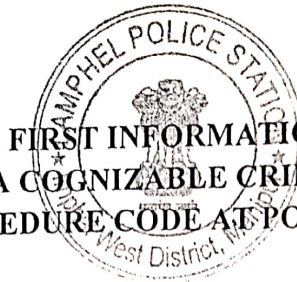

to state a few line for your kind consideration and need-
ful action.

That, on 4/10/2023 at about 7:20pm, my younger
brother namely Chongtham Nganba (33) yrs S/o (L) Ch.
Rajmani of Lamboikhongnangkhang along with his friend
namely Sagolsem Ringku (25) yrs. S/o (L) S. Renjit of
Lamboikhongnangkhang on his motor bike Kawasaki
Caliber (olive Green in colour) bearing registration No.
MN1M-0270, ridden by my younger brother. Coming
from Unipok side toward Lamboikhongnangkhang had
dash at Naothemthong Laishram Leirak near Langol Lai-
rembi steel house, along UK road by one Tata punch
(Dark Grey in colour) bearing registration No. Not known,
driven by unknown driver coming on the same
direction, due to rash & negligent driving on the part
of the unknown driver and fled away towards Jaisem-
ba side. As a result of which, my younger brother
and his friend received severe injury on their head
and their body and evacuated to Rajmedicity Hospital
for medical treatment. The vehicle got partly damaged.

It is therefore, request you to kindly take necessary
action against the unknown driver of Tata punch.
