With due Respect I beg to submit this Application for favour of your kind consideration please.

That on, 4th May 2023 in the afternoon a large group of Meitei community Suspected to be Arambai Tengol numbering more than two thousand attacked Khongsai Veng, Laipham Khunou by carrying Arms and deadly weapons due to communal clash between the two communities. i.e Meitei and Kuki . My family were living in a rented house at Dr. Jamchinlen Lunkim residence S/O T. Lunkim House No. 97 located at Khongsai Veng , Laipham Khunou. On the same day many got injured and some were killed. Due to which I along with my family fled away to save our life leaving behind all our properties in my rented house. After few days our neighbour told me that the house which I stayed was burned down to Ashes. The reason of being delayed in lodging my FIR is being an illiterate person, I have no knowledge of lodging an FIR for taking necessary legal action. It is my relative who told me yesterday i.e on 04/10/2023 to lodge an FIR immediately to Lamphel Police Station for taking up necessary legal action.
