In submitting herewith the enquiry report in c/w the above cited reference, I have the honour to state that on 04/10/2023 the complainant namely Yendrembam Inaobi Leima (43) w/o Y.Biramani Singh of Malom Bazar Maning Leikai lodged a complaint report to OC Lamphel stating that on the intervening night of 03/10/2023 and 04/10/2023 her rice Godown which is located at the opposite side of St. Joseph Higher Secondary School, Sagolband Lukram Leirak near Pukhri Achouba Mapal had been burned by unknown persons. As a result of the burning, one bag of charcoal and two bundles of shacks which were kept inside the Godown were burnt and damaged. The incident was known to me at @ 1.30 pm of 04/10/2023. With such act of the unknown person, the complainant and her family have an apprehension that the unknown persons might repeat the same act in future.

Accordingly, I have enquired into the matter on being endorsed to me by OC Lamphel under **GD Entry No.14/LPS/20232** dated 04/10/2023.

On enquiry examined the complainant who corroborated the OE lodged by her. Visited at the scene of crime and inspected the place of occurrence in presence of witnesses. On inspecting the P.O. the articles mentioned in the complaint report i.e., one bag of charcoal and two bundles of shacks which were burnt by the unknown miscreants were found inside the Godown were seized. Photographs of the scattered spot were also taken from different angles for ready reference. Examined good numbers of PWs who are residing near the spot but none of the PWS could give any due which could give material evidence that happen at complainant's Godown of that intervening night. In due course of the enquiry CCTV footage of that area was monitored which were installed at that place and peripheral areas located at Tera Lukram Leirak near St. Joseph School. After examining the collected video footage of the CCTV cameras, one unknown person was seen driving a two-wheeler who came to the spot and started lighting the fire at @ 1.40 am of 04/10/2023. Hectic efforts have been made to identify the main culprit who was involved in committing the crime. Later, it came to learnt that one woman is highly suspicious involving in committing the offence, but in the meantime one woman namely Yambem (n) Chandani Devi (50) w/o Thiyam Surchandra Singh of Sangaiprou Mamang Leikai surrendered herself before OC-Lamphel Police Station on 07/10/2023 at @ 2:30 pm which she admitted to have committed the crime. Later she was arrested near the Police Station Gate at 2:40 pm by observing formalities in presence of the witnesses. The arrested person along with the seizure memo were handed over to Lamphel Police Station for necessary formalities.

In the above fact and circumstances, it is evident that the person namely Yambem (n) Chandani Devi have involved in committing a cognizable offence u/s 457/436/427/120-B IPC

I therefore, request you to take up necessary action against her and her associates by registering regular FIR case for investigation.
