I am a Government Employee serving as Havildar in Assam Regiment bearing EIN No. 4370266-F. I am presently posted at Kolaba Military Station, Mumbai.

I would like to state that on 4th May, 2023 at around 8pm Meitei community who were suspected to be instigated by valley based Arambai Tenggol and Meitei Leepun had attacked my house at khongsai veng Imphal, PS-Lamphel, Imphal East District was burnt, vandalized, ransacked and looted.

Due to such attacked, fearing to lose our lives, being in state of vulnerability, I along with my family fled from Khongsai Veng Imphal. As such I am presently residing at Kholmun village Churachandpur in one of my relatives.

Total Worth of value/s destroyed Rs. 1 crore, 50 thousands Only

I, therefore seek your timely intervention and register FIR
