Sir,

I have the honour to state that, On 3-05-2023 at 9:00 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL). Arambar Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500 persons carryying deadly weapons and fire arms forcefully entered our locality at Hebron Veng, Phaipijang Langol near Kuki community Hall, Imphal West District Manipur about 45 km South from Saikul-PS and they vandalised and burnt down some neighbouring houses.

On the early morning of 4-05-2023, fearing lost of live self along with my family left our nearby safe location at 143 CRPF house leaving behind all the household properties and fled to camp Lamphel, and later evacuated to Kangpokpi District. As of now we tmeporarily stayed at New Saikul Kangpokpi District Manipur.

Further, it is learnt that on 21-08-2023 at around 12:20 pm some unknown persons suspected to be belonging to Meitei community destroyed my house and looted all the moveable and valueable properties and burnt down my house to ashes leaving us homeless.

The list of properties and documents destroyed are mentioned in the annexure (Enclosed). The approximate value of lost property is calculated at about Rs.9,97,000/- (Nine lakhs ninety seven thousand)

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
