Sir,

I am to state that, I have been stuck at Imphal since May 3, 2023 following mob violence. On May 04, 2023 at 3:48 pm, my residential building measuring an area of 44'x 100'(.8) located at Khongsai veng, Laipham Khunou Heingang A/C, Imphal East was completely burnt down to cinders by violent mob. And along with it, the following properties have been either stolen or burnt to ashes:
