With humble regard I would like to request you to kindly file an FIR regarding damaged and burnt down of my resident due to mob violence on the faithful night of 4th May 2023 at Khongsai Veng House No.113 P.O-Lamlong, PS-Lamphel Imphal East Manipur. The following are details estimated cost value of lost of properties and important documents.

PROPERTIES:-

1. Totally burnt down of simi Pucca house building structure – Rs.70,00,000/- (Seventy Lakh)
2. Kitchen materials including Utensil – Rs. 172,000/- (One lakh Seventy two thousand)
3. Three wooden bed and one smart Sofa set – Rs. 192,000/- (One lakh ninety two thousand)
4. One flat TV and One Laptop – Rs.137,000/- (One Lakh thirty seven thousand)
5. Two steel Almirah and two small plastic almirah – Rs.142,000/- (One lakh forty two thousand)
6. Basic needs and clothing with 17 blanket – Rs. 70,000/- (Seventy thousand)
7. Bathroom (2 western toilet + 1 washing machine – Rs. 82,000/- (Eighty two thousand)
8. 01-Two Wheeler Vespa – Rs 82,000/- (Eighty two thousand)
9. Cash – Rs.2.5 Lakh
