I, the undersigned have the honour to state that large numbers of innumerable unidentified groups of People belonged to Meetiei Community, Arambai Tenggol, Meetei Leepum, State Commendo stormed to all our village Langot, Hill Side Colony, Imphal on 3rd/4th May, 2023 at around 4:00 pm. The said unidentified groups vandalized/burnt down my house and looted all valuable items in that unfortunate incident. I have lost a total amount of about Rs 50,00,000/- after the said unfortunate incident/mob violent my family are fleeing our village and now my family is taking shelter at a relief camp Moreh Govt. Higher Secondary School, Moreh, Tengnoupal District, Manipur.

It is therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused person and persons involved in the said inhuman act and heinous crimes committed by the accused persons and persons involved as per law of the land as early as possible.

I shall be grateful for your kind cooperation and necessary actions.
