I have the honour to state for kind consideration and necessary action that one team of Lamphel PS led by me have conducted NAKAS frisking & checking and also conducted patrolling in and around RIMS Hospital Campus in c/w the daily vehicles theft report at RIMS Campus. While patrolling towards Gynae ward, two unknown persons are trying to unlock an NTORQ-125 two-wheeler vehicle bearing registration No. MN06SG-9316. Accordingly, two persons are detained at Gynae road behind Special Ward parking. On questioning they identified themselves as 1) Md. Sadik Khan (26) S/O Md. Samsuruddin of Lilong Haoreibi Awang Leikai and 2) Md. Aariyam @ Achouba (16) S/O Md. Sagir Ahamed of Lilong Haoreibi Awang Leikai, and they are trying to steal the NTORQ. Further they are arrested from the spot at 6.30 pm also seized one car Key and T-Shape tool from the possession of Md. Sadik Khan (26) S/O Md. Samsuruddin of Lilong Haoreibi Awang Leikai and further seized the NTORQ-125 two-wheeler vehicle bearing registration No. MN06SG-9316 at the instance of Md. Sadik Khan. The arrested persons and seized articles are handed over to you for further necessary legal proceeding.
