Dear Sir/Madam,

I am to report that on 4<sup>th</sup> May, 2023, in the evening, some unknown miscreants have forcibly entered my house by breaking the lock and key of the Gate and Main Door, while I along with my family were taking shelter at 143 Battalion CRPF, Lamphel Camp, near DC Complex, Imphal West due to the current ongoing communal clash.

In this matter, I am to report that the miscreants looted the following household items/fixtures and furniture/personal belongings, etc from my residential house located at Hebron Veng, Phaipijang, Langol, Imphal West.

As reported in the above tables, I am to report that the miscreants have looted household goods, furnitures and fittings, etc. Amounting to value of ₹ 34,25,500/- (Thirty Four Lakhs Twenty Five Thousand Five Hundred Rupees).

In additions to the above looting of household items and properties, I am also to report that the miscreants have caused major structural damage to the residential building including the Main gate, main door, windows, ventilators, roofings, garage, etc. The damage inflicted on the physical structure of my residential property is of more than ₹ 15,00,000/- (Fifteen Lakh Rupees) value.

Therefore, I am to report that the total loss from looting and damage to my residential house is approx. ₹ 49,25,500/- (Fourty Nine Lakh Twenty Five Thousand Five hundred Rupees).

In view of the above report, you are therefore requested to kindly take necessary legal action so as to recover my looted properties at an early date. I also urge you to take swift action to bring these criminals to justice. I requested that you launch a thorough investigation into the matter and bring the culprits to book.

I request you to take this matter seriously and to act swiftly to ensure that justice is served. The report couldn't be filed in time as we fled from our residence due to danger to our life and physical safety, under the given circumstances. Thank you for your attention to this matter.
