With due respect, I the undersigned would like to introduced myself as Upa Ralrunthang who is one of the members and elders of the church of WESLEYAN METHODIST CHURCH OF EAST INDIA IMPHAL WMCEI (ICI) located at Langol Phaipijang P.O & P.S- Lamphel & District- Imphal West and would like to make a report to your good office about vandalism, destruction and Looted of properties which are inside the Church building of WESLEYAN METHODIST CHURCH OF EAST INDIA IMPHAL WMCEI (ICI) located at Langol Phaipijang P.O & P.S- Lamphel & District- Imphal West on 04-05-2023 at 11:00pm by Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun.

At the very outset, that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on the said day of 04-05-2023 some Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun enter the compound of our Church at around 11:00 pm started to vandalized, destruct and looted all the properties which were kept inside the Church worth Rs. 90,60,000/- (Rupees Ninety Lakh and Sixty Thousand) only. I could not make the report on time because I could not reach my native place due to displace from Imphal and have to take shelter at the place of my relative at Mizoram and could make the said report after reaching my native place at Rengkai Village.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future.
