On 06-05-2023 around 4:00 pm in the evening the lock of my rented quarter was destroyed by Meeitei/Meitei's goons, they vandalized and looted all of my properties worth Rs.9,00,000/-(Rupees Nine Lakh) only on the said day.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future. I could not make the said report on time as I could not reach my native place on time after running out from Imphal City for saving my life and family life.
