With due respect, I have the honour to state that on 7/12/2023 at about 4:50 pm while my father namely Lourembam. Shyamkishore Singh aged about 63 years was walking on the roadside of Iroisemba Lourembam Leikai. Suddenly one Kwid Climber Silver in colour bearing regd. No. MN01AW-8998 driven by an unknown driver coming from Iroimsemba towards Naoremthong had hit my father due to his rash and negligent driving. My father received injuries on his head. Immediately, my father was evacuated to Shija Hospital, Langol by the said Renault Kwid car driver. I was busy at hospital for treatment of my injured father and I could not report the matter at concerned police station in time.

It is therefore request to take necessary action against the accused person. Thanking you for your kind co-operation.
