With due respect I am to state the on 24/04/2023 I left my car – Renault Duster B/Regd. DL8CAK7518, Chasis No. MEEHSAW5F3085996, Engine No. E009890, White colour, registered in the name of father namely Tongkhotinthang Hangshing of Kangchup Chingkhong, at Etao Workshop, Lamboi Khongnangkhang, Imphal West, for repairing. That, due to the present communal violence I could not get it back.

That, a few days back I came to learnt that some unknown personnel of Arambai Tengol had forcibly took it away from the said workshop possibly on 3/08/2023 at about 11 am. Which amounts to extortion, causing wrongful loss to us. The Car is worth 12,000/- .

It is therefore requested to kindly take up neccy. legal action to recover my vehicle and punish the culprits as per law.

I was not informed timely of the extortion of my car, hence the delay in reporting.
