Sir,

With due respect, I the undersigned would like to make a report to your good office about vandalizing and looting of my Readymade Garments, Sewing Machine & women Garments material (Cloths) from my Tailoring shop located at Langol Jeep Parking, Leima Khulem Leikai, Imphal, P.O & P.S- Lamphel & District- Imphal West on 06-06-2023 at around 6:00 PM by a group of Meeitei/Meitei's along with some women numbering 500 to 600.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on dated 06-06-2023 at 6:40 pm the lock of my shop was destroyed by a group of Meeitei/Meitei's, they vandalized and looted all different style of my Readymade Garments, Sewing Machine & women Garments material (which was stock inside the store) from my Tailoring shop and with Garments Materials which we used for stitching women garments and some other items which worth Rs. 8,43,000/- (Rupees Eight-Lakh and Fourty Three Thousand) on the said day.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future. I could not make the said report on time because I have to flee from my rented resident Imphal to Mizoram and stay they till date due to the problem situation which unable me to file said report on tim. Presently I came back from Mizoram and stay at my relative resident at Rengkai village.
