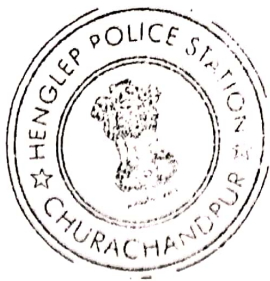

05-202 at 6:00 pm the lock of my rented gate of the compound was destroyed by a group of unknown  
Meeitei/Meitei's they looted all my different variety of wood which were kept and stock in the godown for  
used in my furniture shop which worth Rs. 10,00,000/- (Rupees Ten Lakh) of my property. I could not  
make the report on time since I run out for my life from Imphal, I am taking shelter at my relative  
resident and the shock still grip me which I could not recover to make the report on time. All the good  
were purchased from the Loan money which I avall from Bank of Baroda, RIMS Branch

It is requested to your good office to make entry of my report a Zero F.I.R and take action  
against the perpetrator as per Law and also issue me the copy of the said report for my reference in
