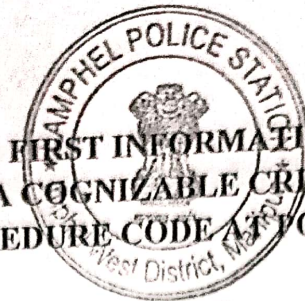

With due respect, I the undersigned would like to make a report to your good office about vandalizing and looting of my wood carpentry Shop under the name and style of Wright wood Furniture Shop located at Lamphel PDA Complex Bazar, P.O & P.S- Lamphel & District- Imphal West on 20-05-2023 at 6:00 PM by a group of unknown Meeitei/Meitei's.


At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on dated 20-05-202 at 6:00 pm the lock of my shop was destroyed by a group of group of unknown Meeitei/Meitei's they vandalized and looted all my tools and machines used for my wooden work and some other items which worth Rs. 10,47,3237/- (Rupees One Core Four Lakh Seventy Three Thousand two hundred and Thirty Seven) of my property. It may be pointed out that all my machine were purchase from the Loan amount I avail from Bank of Baroda, RIMS Branch. I could not make the report on time since I run out for my life from Imphal, I am taking shelter at my relative resident and the shock still grip me which I could not recover to make the report on time.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future.




