The criminals broke opened the gate and destroyed, looted, vandalized and burn down my residential semi pucca house and other belongings comprising of the followings-

- 1.One semi pucca house worth Rs.24lakhs (Twenty-four lakhs only)
- 2. Furniture set worth Rs. 2 lakhs (Two lakh only).
- 3. Electronics Gadgets worth Rs. 1 lakh (One lakhs only).
- 4. Essential commodities worth 2 Lakhs (Two lakhs only)

The total loss is estimated to be in region amounting Rs.29,00,000/ (Twenty nine lakhs) only. Fortunately, all family members managed to escaped from the criminals.
