Sir,

I am to report that on the 04<sup>th</sup> of May, 2023 at about 1:30 pm, my residential home, owned and registered in my name bearing patta no.160,350/4180, dag no,63/1205, situated at 91 meitei langol, Game village, Imphal west, was attacked by Meitei miscreants.

The criminals broke opened the gate and destroyed, looted, vandalized and burn down my residential semi pucca house and other belongings comprising of the followings-


1. One semi pucca house worth Rs.24lakhs (Twenty-four lakhs only)
2. Furniture set worth Rs.2lakhs (Two lakh only).
3. Electronics Gadgets worth Rs.1lakh (One lakhs only).
4. Essential commodities worth 2 Lakhs (Two lakhs only)

The total loss is estimated to be in region amounting Rs.29,00,000/ (Twenty nine lakhs) only. Fortunately, all family members managed to escaped from the criminals.
