Sir,

I, Ginalmuon Kipgen, a B.Tech, Computer Science and Engineering dept., 5th semester student at National Institute of Technology, Manipur (NITMN), a resident of Churachandpur, Manipur, am writing to bring to your attention a grave incident of vandalism and looting that occurred at Boys' Hostel No. 2, NIT Manipur, Langol.

On the day of May 4, 2023 at around 7:00 AM, due to escalating violence in and around Langol, Imphal, my three roommates and I were compelled to evacuate Room A-10 in Boys' Hostel No. 2, NIT Manipur, for our safety. Following the guidance of the police, we sought refuge at the 1st Manipur Rifle Ground, Imphal. Before leaving the campus, I responsibly secured my room by locking both my locker and the door. I obtained permission from the hostel warden, before leaving the hostel premise. Given the prevailing law and order situation, my roommates and I have been unable to physically return to the hostel. Following the advice of the Deputy Commissioner, Churachandpur, we requested our friends in campus to pack our belongings on our behalf to make it convenient for the retriever. Regrettably, a reliable information was received that on December 10, 2023, around 10:00 AM my room had been subjected to extensive vandalism and looting. The room was discovered in a state of disarray, altered from its condition when I vacated the premises. My clothes were scattered and soiled. A preliminary assessment of the destroyed and looted items indicates a collective loss of approximately ₹35,000.

I hereby request your immediate intervention and kindly seek your cooperation in registering an FIR under the relevant sections of the Indian Penal Code against the perpetrators involved in this heinous act of vandalism and theft. I trust that the Churachandpur Police will undertake a thorough investigation to bring those responsible to justice. I am willing to cooperate fully with the police during the investigation and provide any necessary information to expedite the process. I believe that your prompt action will not only provide justice in this case but also contribute to maintaining law and order within our community.

Thank you for your attention and anticipated cooperation in this matter.
