These criminals broke/open my gate(s), destroyed and looted every valuable property from my House worth Rupees 35 Lakhs (aprox) and they burnt down all the remaining.

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal slogans.

I therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant section of Law(s)
