Sir,

I would like to bring to your attention the following fact of the case regarding the fate of the aforementioned vehicle.

That, due to public riot in Imphal I was compelled to stay at 86Bn CRPF camp at Lamphel from 4th May, 2023 and parked my car near the camp in front of Kendra Vidyalaya Central School, Lamphel as directed by the security personnel. On 6th May, I went to check on my car and found that both the rear wheels were stolen and the glasses broken (photo enclosed). As the situation escalated in the City I was compelled to leave Imphal for Shillong.

Meanwhile, on the 13th May 2023, some friend on my request went to check on my car again but they were unable to find my car which probably might be stolen. As the situation in the city still remain tense, I am personally helpless to search out.

As I am unable to return to Imphal due to the tense atmosphere, I am therefore, compelled to file Zero FIR at your esteemed station and request you to kindly process necessary action from your end, for which I shall be grateful to you.
