Sir/Madam,

I, Lalrammawi, the undersigned, residing at All India Radio Staff Quarter, Pohkseh, Shillong would like to register a First Information Report (FIR) regarding a significant theft of property that occurred at our official residential quarter in AIR Staff Colony Imphal during the recent Manipur violence. The incident took place on 15<sup>th</sup> June 2023 between 3 PM to 5 PM.

**Details of the incident:**

**Date and Time of Incident:** 15h June 2023, between 3 PM to 5 PM.

**Location of Incident:** Qtr. No. 15, Type III, All India Radio Staff Colony, Imphal, Manipur.

**Description of the Incident:** A mob of around a hundred unidentified individuals forcefully entered the Central Government Residential Premises amidst the ongoing Manipur violence. They proceeded to commit theft of valuable properties present within the premises.

I hereby request your esteemed police department to take immediate action to investigate the incident, apprehend the culprits responsible for this theft, and recover the stolen property. Kindly keep me informed about the progress of the investigation.
