Churachandpur belonging to Paite Scheduled Tribe would like to report that I am staying in a rented house with my whole family at Langol Lamkhai, Near Shija Hospital P.O.& P.S. Lamphel, Imphal West and due to the ethnic clash I am force to fled from our house leaving behind my property at the mention address in Langol Imphal.

That, on the 5<sup>th</sup> August 2023 at around 6:00 pm unknown volunteer from Meitei community looted my house as mention above incurring an estimated property loss amounting a value of about Rs. 2,00,000/- (Rupees Two Lakhs only)

I therefore pray that you kindly initiate necessary action at the earliest for the end of justice.
