Lamphel, Imphal West and due to the ethnic clash I am force to leave my place of work and house leaving behind my property at the mention address in Langol Imphal.

That, on the 5th August 2023 at around 6:00 pm unknown volunteer from Meitei community looted my house as mention above incurring an estimated property loss amounting a value of about Rs. 3,00,000/- (Rupees Three Lakhs only)

I therefore pray that you kindly initiate necessary action at the earliest for the end of justice.
