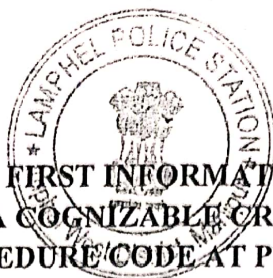



Subject: Report of looting at Langol Lamkhai, Lamphel.

Sir,

I Smt. Maman Giute age about 49 years w/o (L) Vumlalven Guite a resident of Vengnuam South New Lamka, P.O. New Lamka P.S. Churachandpur belonging to Paite Scheduled Tribe would like to report that I am staying in a rented house at Langol Lamkhai, Near Shija Hospital P.O. & P.S. Lamphel, Imphal West and due to the ethnic clash I am forced to leave my place of work and house leaving behind my property at the mentioned address in Langol Imphal.

That, on the 5<sup>th</sup> August 2023 at around 6:00 pm unknown volunteer from Meitei community looted my house as mentioned above incurring an estimated property loss amounting to a value of about Rs. 3,00,000/- (Rupees Three Lakhs only)

I therefore pray that you kindly initiate necessary action at the earliest for the end of justice.
