Sir,

With due respect I, Hehat Haokip age about 62 years w/o Onkhomang Haokip a resident of Phaipijang, Langol P.O. &P.P.S. Lamphel District Imphal West presently staying at Ideal School, S.Canan Veng, Tuibuong P.O & P.S. Churachandpur would like to report that due to the ethnic clash in Manipur, I along with my family members fled from our house leaving behind all our property as it became direct threat to our life taking shelter at Leimakhong Assam Rifle Camp after which we were evacuated towards Churachandpur.

That, on the 12th August 2023 at around 9:00 am Meitei radical believed to be member of Arambai Tengol and Meitei Leepun, came and attacked our resident area by burning all houses belonging to the Kuki-Zo Community causing mental agony and material loss estimated to be at a value of Rs.27,43,000/- (Rupees twenty Seven Lakhs Forty Three Thousand only).

It maybe mention that my vehicle (1). Gypsy (Maruti Suzuki) MN-06 LB 0134 (2). KTM Motor Bike Reg No. MN 01 AF 3211 (3). Scooty Pleasure Reg. No. MN01 AL 7730 (4) Scooty Vespa Reg. No. DL14 SH 5519 and my household property were burnt down in this criminal activities.

Therefore, I would like to request your kind office to initiate necessary action at the earliest so the culprit of this crime may be booked under the relevant provision of Law.
