Sir,

With due respect I, Klmkholhing Haokip age about 60 years w/o Satkhothang Haokip a resident of Phaipijang, Langol P.O. &P.P.S. Lamphel District Imphal West presently staying at Ideal School, S.Canan Veng, Tuibuong P.O & P.S. Churachandpur would like to report that due to the ethnic clash in Manipur, I along with my family members fled from our house leaving behind all our property as it became direct threat to our life taking shelter at Leimakhong Assam Rifle Camp after which we were evacuated towards Churachandpur.

That, on the 12<sup>th</sup> August 2023 at around 9:00 am Meitei radical believed to be member of Arambai Tengol and Meitei Leepun, came and attacked our resident area by burning all houses belonging to the Kuki-Zo Community causing mental agony and material loss estimated to be at a value of Rs.90,00,000/- (Rupees Ninety Lakhs only) including of my Semi Pucca House along with all the property in it.

It maybe mention that all our original educational certificate/document of both me and my husband were lost in this criminal activities,

Therefore, I would like to request your kind office to initiate necessary action at the earliest so the culprit of this crime may be booked under the relevant provision of Law.
