Subject - Report on crimes of criminal intimidation, unlawful displacement, vandalism, looting and discrimination of Scheduled Tribes.

Dear Sir.

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the any Kuki Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989. And, I am a permanent resident of Hill Side Colony, Phaipijang, Langol, P.O. & P.S. Lamphel, District-Imphal West, Manipur.

That, on the 1st of August,2023 at about 10:00 AM, a huge contingent of armed radical belonging to the Meitei/ Meetei community suspected to be members of Arambai Tenggol and Meetei Leepun, looted and vandalized our properties.

That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobod would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 1,50,00,000/-(Rupees One Crore Fifty Lakhs) Only.
