

**Subject: Arson Reports.**

Dear Sir,

I, Rosy Themboi Haokip age about 38 years W/O Thangkhoen Khongsai resident of Langol Housing Complex, Type II B-45 P.O & P.S. Lamphel Imphal Weast presently staying at Family Lane Bijang , Tuibuong P.O.& P.S. Churachandpur. Would like to report that, I am the owner of electrical goods shop, Red. No.IMC/103(5)/20 GST No. 14ARZPH4328J1ZD registered as M/S EIMI HARDWARE AND ELECTRICAL STORE at Hebron Veng Langol, Imphal West and that due to the communal violence a group of Meitei miscreant attacked our shop on the 3<sup>rd</sup> day of May 2023 at around 8:00 pm using petrol bomb burning all shop belonging to Kuki Zo community in the area fearing for own safety I fled toward CRPF Camp Lamphel leaving behind my shop which ultimately burnt to ashes. The total value of loss in this arson is estimated at Rs.4,500,000/-(Rupees Forty Five Lakhs).

That, I am filing this report at the earliest possible time after returning from Dimapur, Nagaland on 26<sup>th</sup> August 2023 where I take temporary shelter.

I, Therefore would like to request your office to look into the matter and initiate necessary action at the earliest for the end of justice.

For which kind act of yours I will remain thankful to you.
