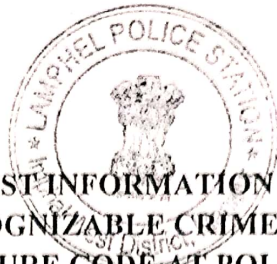

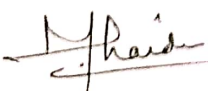

I and my family were residing in the above address since 14 years. On the 4th of May 2023, we were ordered to move out of the house by The Aron Tchoh Misra or else they Threatened that they would kill us. He we moved with the protection to CRPF camp, Lamphel, and we plan to Shillong. Once we moved out of the house, on the same day they looted and burnt our property.

I had to flee since I was a kuki, we still fear for our life. I am an AAO, A.G. Office, Imphal and I don't know when I can go back to my job. I had possession including electronic, vehicles, jewel worth 40,00,000/- in my house and there is nothing left in the house.

Due to this incident I and my children had been put to great hardship and mental trauma.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back. We ~~request~~ are hoping for Justice for us and for all we are in this situation.
