Respected Sir.

We are the residents of the above address for 12 years now. On the 4th May, 2023, Meitei mob from the nearby locality started burning and vandalizing tribal houses near our house. My house, which is also a private school was not touched. On 6th May 2023, the mob returned looting and vandalizing houses again. On receiving threatening calls, I sent female family members and children on 10th May 2023 to Shillong. On the 11th of May 2023, a Company of Border security Force (BSF) entered our campus to put up camp there. Thinking that we were safe, we stayed back. But on 4th June 2023, we received another threatening call again and we were forced to leave our house with some bare clothing only with no time to even lock our house properly. We were

promptly escorted to CRPF camp at Lamphel. The nest day, we took a flight from Imphal to

Guwahati and reached Shillong.

Who were the one's who attacked you? Meitei radical groups such as the Arambai Tenggol and

Meitei Leepun, because we are non-Naga tribal Christians. I am a Private school owner. I have 4

children and all of them are studying. My properties which were being damaged by the miscreants

amounted to 13.21 crore Rupees. My possession in the house was worth 100,00,000/-. My vehicles

have been damaged- 1 SUV, 1 car, I van, 3 two-wheelers & 1 cycle (Totaling 21 lakhs)

Hence, we request you to restore the situation to normalcy and to me, the only way we could live

normally again through separate administration. I hope I could get some compensation and is able

to start a new life from scratch.

We are hoping for Justice for us and for all who are in this situation and to book the culprits as per

sections of the Law.
