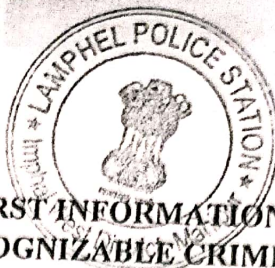

I AND MY FAMILY WERE
RESIDING IN THE ABOVE ADDRESS SINCE ²³ YEARS,
ON THE 3rd OF MAY, 2023 THE ARAMBAI TENGOL
MISCREANTS AND THE MEETEI LEEPUN ATTACK OUR
AREA AND WE SAW HOW MANY FROM OUR
PEOPLE FROM THE TRIBE HAD BEEN ATTACKED.
HENCE WE MOVED WITH THE PROTECTION OF
THE CRPF 143 BATTALION DC, LAMPHEL. AND AFTER
A WEEK WE FLEW TO SHILLONG. ONCE WE
MOVE OUT THE HOUSE ON THE SAME DAY, THEY
DESTROYED OUR HOUSES AND THEY BURN
DOWN OUR MOTOR CYCLES.

TO FLEE SINCE I WAS A RUKI, WE
FEAR FOR OUR LIFE. I AM A
DUDENT AT IMPHAL AND NOW I DON'T KNOW
WHEN I CAN GO BACK TO MY SCHOOL. I HAD
POSSESSIONS INCLUDING ELECTRONICS, VEHICLES,
CLOTHING STORE, KITCHEN PROPERTIES, AN HOUSE
PROPERTIES WORTH RS: 1,663,000/- A
MOTORBIKE AND A HONDA ACTIVA 6W WORTH
RS: 183,000/- AND I HAVE NO IDEA IF
ANYTHING IS LEFT AFTER THE BURNING
DOWN OF MY HOUSE BY THE MOBS.

DUE TO THIS INCIDENT I AND MY FAMILY HAVE
BEEN PUT TO GREAT HARSHIP AND MENTAL
TRAUMA.

HENCE, I REQUEST THAT YOU WILL INVESTIGATE
THE MATTER AND TAKE PROPER ACTION AGAINST
THE SITUATION TO NORMALCY AND PROVIDE
PROTECTION FOR US TO GO BACK AND RE-
BUILD OUR LIVES BACK IN OUR LOCALITY.

WE REQUEST THAT YOU WILL ALSO
PROTECT OUR PROPERTIES AND THE
WHOLE LOCALITY FROM ENROUCHMENT.

WE ARE HOPING FOR JUSTICE FOR US
AND FOR ALL WHO ARE IN THIS SITUATION.
