We are the residents of the above address since 2002 till this date. On the night of 3rd may around 7:00 pm Meitei mobs who we believe are the Meitei Arambai tengol and the Meitei leepun along with the locality Meitei's who are known to us try to forcefully entered our house and tried to attack us. Some of them were armed with guns and knives and all sort of things. I hide my 5 children under the bed because I was scared for their lives. Scared the mob would kill us. After awhile we hide around our house tunnels waiting for them to move out. The next morning the CRPF came to escort us out. And we were move to the relief camp. They destroyed all our belongings and looted all of them once we move out and after that they burned down our house.

We believe we were attacked solely because we belong to kuki community. Because the mob shouted and chanted (Kuki macha hatlo) meaning when translated (Kill all kuki people). The attack was a pre planed as they marked our gates with red mark to identify all kuki houses.

I am a housewife, my husband is a Manipur police holding the position sub-inspector and posted at Litan. We have suffered financially tremendously. The estimated amount of properties destroyed is Rs 30 Lakhs 52 thousands. A cash amount of Rs 1 lakh was also looted from our room along with our furnitures, electronic appliances which were worth upto Rs 80,000.

This mayhem which is cause by the Meitei arambai tangol and the Meitei leepun have cause me a lot . I have suffered from PTSD along with palpitations after the attack. Always tense and fearful whenever I heard a loud noise from afar.

Hence, I asked the higher authority to compensate me for my lost and bring justice for me and my family. And to book the culprits as per section of the law.
