Respected Sir,

I am residing in the above address since 10 years. On the 4th May 2023 I am ordered to move out of the house by the Arambai-Tengal miscreants or else they threatened that they would kill me. Hence I moved with the protection of police commandos to 1st Manipur Rifles HQ and next day I flew to Shilong. Once I moved out the house on the same day they burned down my whole house.

I had to flee since I was a kurki, I still fear for our life, I am a teacher in lower primary school and now I don't know I can go back to my job or if my salary will continue to be paid, I have possession including my original certificate and all my original documents like plot data, service card, Aadhar card, Bank pass book etc. House hold goods, jewels worth Rs. 5000000/- In my house in itself costed Rs. 90,00000/-

and at 10:00



110 grand vehicle worths Rs, 7,00,000/- Lakh
Eon vehicle worths Rs, 4,00,000/- Lakh
and Two wheeler vehicle worths Rs, 1,20,000/-
and I have no idea if anything is left
after the burning down of my house by
the mobs

Due to this incident I and my son
have been put to great hardship and
mental trauma, Hence I request you that
you will investigate the matter and
take proper action against the perpetrator
as well as restore the situation to
normalcy and provide protection for us
to go back and rebuild our lives back
in our locality. We request that you
will also protect our properties and
the whole Locality from encroachment.

We are hoping for justice for us
and for all who are in this situation
