We are residents of the above address since 2013. On May 4th the mobs attacked our area and we saw how many of our people from the tribe had been attacked and hence, we had to flee from our residence and take shelter in the camps, but on the way our vehicle(Eco Van) was stopped and burnt by the mobs and we were sent back to our homes. Later in the night the assam rifles came and took us to the camp at night and that's how we survived. Then from the camp the Nagaland police took us to Dimapur and then we moved to Shillong for residence. Due to this we went through a lot of mental trauma.

I and my family were targeted because we were from the Kuki Tribe and we don't feel safe about going back to our home. I was working in the Manipur police and my children were studying in the Schools back home and now I can no longer work and I heard that I may not get paid from next month. My children also cannot continue their education because of us leaving from Manipur. Along with financial losses, now I no longer have a vehicle to travel too.

We also got to know that there has been theft in my area and the miscreants have stolen my TV which costed 32000/-, Almirah that costed Rs. 48,000/-, another almirah that costed Rs.11,000/-, A godrej costing Rs.17,000/-, cot with storage worth Rs.15,000/-, cloths and other things that cost approximately Rs. 1,50,000/-, a gold worth Rs. 1,44,000/-, 4 traditional necklace worth Rs. 60,000/-, Elecronic items and kitchen items worth 80,000/-, 7 fans worth 14,000/-, 4 bed and mattress worth 1,00,000/-, 5 syntex tank of 500 litre worth Rs. 2200/- each and mainly our
