Sir.

With due respect I, the undersigned, a social worker by profession have to state the following few lines for your kind perusal and necessary action with reference to the above subject matter:

1. That the Government of Manipur in order to combat the rising menace of drug trafficking & drug abuse in the State under a Government policy declared "War on Drugs" and campaigned to destroy illegal Poppy plantation in the hilly regions of the State. In consequence of this Government Policy, the 12th Manipur Legislative Assembly on 3.3.2023 in its 3rd Session adopted a unanimous resolution irrespective of party lines thereby designating all the 60 (sixty) Members of the House (MLAs) as Warriors of "War on Drugs".

As a result of the hectic campaign of the State Government, 18,664.5 acres of poppy cultivation were destroyed and 2,518 individuals belonging to different communities have been apprehended under ND&PS Act, during the period from 2017 – 2023. This move of the State Government has infuriated the Drug Lords of the Drug Cartel as it caused huge loss to their Drug related business. Most of the Drug Lords, Poppy planters belongs to foreign nationals of the neighboring country Myanmar who illegally entered no State and one particular community of the State.

Not only this Government Policy of War on Drugs, the State Government also hectically campaigned for protection of its Reserve Forest and Protected Forest from illegal encroachments. As a result, many illegal encroachments inside the Reserve and Protected Forests were evicted. The State Government also initiated action for survey of Forest Areas in association with the State Revenue Department. This irritated the illegal encroachers who mainly belong to Chin Kuki community.

Moreover, by constituting a Cabinet Sub-Committee headed by Mr. Letpao Haokip, a minister belonging to Chin Kuki Community started to identify illegal immigrants mostly from Myanmar by conducting spot enquiries.

 - 3. That while the State is under a state of turmoil because of the ongoing violence certain people taking the advantage of the situation are actively involved in the escalation for further continuation of the violation in order to achieve their political gain and for personal vendetta thereby endangering the lives of many innocent citizens.
 - 4. That on 13.8.2023 on the occasion of Patriot Days at South Barak Cachar, Thounaojam Brinda in her public speech has instigated the general public as there is no other way other than waging war against India. According to her, it is India to destruct Manipur or Manipur to destruct India, there is no other way to save Manipur. The hate speech of Thounaojam Brinda is still available at You Tube https://www.youtube.com/watch?v=Jb3l-GfZ Sk. In her speech, she not only instigated for waging war against the Union Government but also alleged the direct involvement of Manipur Government in the Drug Cartel and is a part of the narco-terrorist and these allegations are made by her for some selfish motive i.e. to instigate the innocent people to

have a feeling of hatred or contempt against the government established duly by law (Video and screenshot photo enclosed)

- 5. That it may also be worth to mention herein that in one of the litigations filed in the Court of Civil Judge (Senior Division), Imphal East, Manipur Smt. Thounaojam Brinda had admitted that Shri N.Biren Singh, Hon'ble CM never told her directly any of the Statements contained in the affidavit which are defamatory. And the above mentioned can be ascertained from the relevant case records during the process of investigation.
- 6. That previously one WhatsApp conversation amongst the members of one WhatsApp Group "VOICE of ZALENGAM 2" comprising of mobile numbers (i) +91 84596 03715, (ii) +91 6909 541 579, (iii) +91 96566 67224, (iv) +91 70021 29077, (v) +91 86707 05610, (vi) +91 6909 113 696, (vii) +91 70057 24183 etc. was also gone viral. In the said conversation it is stated as follows –

"GOOD NEWS

Dear Brothers and sisters, we have come this far and we should not give up.

We have worked this hard and now, we have to use the meiteis to achieve our goals. Let's remember the proverb 'Keep your friends, and enemy closer'.

Brinda Thounaojam has helped us a lot with her vague moves. WE SHOULD SUPPORT BRINDA IN ORDER TO GET RID OF CM N.BIREN SINGH.

We have successfully got TH Radheshyam and Brinda on our side. It was with their help that the video reached the National and international media, making it a turning point of our dream. We already gave Brinda two crores beforehand to put her on our side.

Let the Central leader know that the Meiteis are a threat to the National Integrity.

SEPARATE ADMINSTRATION IS A MUST FOR US!"

As such, there is high possibility of close nexus between Smt. Thounaojam Brinda, aged about 44 years, W/o. Rajkumar Chinglen of Yaiskul Janmasthan, PO & PS Imphal, Imphal West District, Manipur, a candidate at the 12th Manipur Legislative Assembly Election from 14-Yaiskul Assembly Constituency and various Kuki organizations including ITLF, KNO, KNA, KNF, ZRA, ZALENGAM, Zomi Chief's Association etc., for escalating the present

ongoing violence in Manipur so as to meet their personal gain by committees amongst the different communities who are settled in the state Manipur and her statements under the influence of narco-terrorists and supporters like Zomi Chief's Association etc., have seriously threatened National Security of India. It is also evident from her continuances of speech against the Meitei community and Meitei politicians without providence to support the same are mainly due to the said acceptance of Crores by Smt. Thounaojam Brinda from various kuki organization admitted/stated by the persons belonging to kuki community in WhatsApp Group "VOICE of ZALENGAM 2" and going by the allegation Zomi Chief's Association, it is highly suspected that Zomi Chief's Association has also contributed huge amount of money to bribe Smt. Thounaojam Brind: the ones who actually fought the War on Drugs, it is people like the Minister of Manipur Shri N. Biren Singh who is the true patron in the drug business." - 8. Adding to this spreading of such false and unaccounted news, one Bliss Niangngaihvung Singson @BlissAmbassador was posted the above-mentioned false story. Further, in the said post it is further stated that 'Our demand for separate administration stands strong and resolute. It is the only viable solution to protect our community, preserve our culture, and ensure lasting peace in Manipur. It's time for truth, justice, and a future free from falsehood.' (Screenshot enclosed)
- 9. All these statements appear to be interlinked and a planned move to escalate and intensify serious law and order situation and communal riots in the State of Manipur and its attempt to stop the prevailing narco-terrorist activities in the State of Manipur. And the same amounts to promoting enmity between different groups/communities on grounds of religion, race, place of birth, residence, language, etc., and doing acts prejudicial to maintenance of harmony in addition to waging war or instigating to wage war against the Union of India.

The Complainant came to know about the existence of such statements available in the social media only on 19th August, 2023 which is within

jurisdiction of this Police Station and it has been obtained from my colleague. counsel and print copy has been in my possession.

It is, therefore, requested you to take up necessary legal action by holding a thorough investigation after registering a case under the relevant provisions of law as provided under section 121, 153A read with 120, 505, 120B, 420, bribery, threat to National Security, extortion, etc., under IPC so as to punish the all the said accused in accordance with law of the land.
