

That, I am a scholar pursuing my research under Manipur University (M.U.) bearing **Admission Registration No 4425/20** located at Canchipur, P.O. & P.S.- Singjamei and district- Imphal East-795003, rented a house owned by *Albert Thangthasiem(9856809885)* located at 3<sup>rd</sup> Street, New Lambulane (Hmar Veng), P.O. & P.S.- *Porompat* and District- Imphal East-795005.

That, on the **3<sup>rd</sup> of May, 2023** at around **7:15 AM**, I left for Mata Village, CCpur Dist. to attend family gathering and worship service and due to the ethnic crisis, I couldn't return back to Imphal to continue with my Research. I would also like to add that I have deserted my Two-Wheeler (Automatic Scooter), make & model is Yamaha Fascino which is Red in Colour, whereas, the documents and other details of the said vehicle are in the trunk of the said vehicle.

That, it may be mentioned here that my research materials along with my personal belongings which I deserted are estimated to be worth about **Rs.3,50,000/- (Rupees Three Lakhs Fifty Thousand)** Only. Therefore, I would also like to add that, I have been facing difficulties in going to the Valley/ Imphal area to continue our studies or research. Hence, *many of us, especially the Research Scholars have stopped receiving our scholarships and other facilities.*

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and, for which act of kindness, I shall always remain thankful to you and obliged. And, thus I am filing the report lately today.
