Subject – Report on crimes of vandalism and looting of properties / discrimination of Scheduled Tribes.

Dear Sir/*Madam*

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Hmar Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**.

That, I have purchased an apartment @**Olive Cottage** which comprises of 8(eight) Flats (rented houses) , from my relative namely, **Rosiem Pudaite (8416097069)** but the Ownership is still under his name, and due to the prevailing ethnic crisis in and around Imphal, 6(six) deserted Flats from the apartment was vandalized and looted by the Meeitei/Meiteis suspected to be members of Arambai Tenggol and Meetei Leepun, as 2(two) Flats were occupied by the Family belonging to the Naga Tribes, which is located at New Lambulane, Checkon, **P.O. & P.S.- Porompat**, district- Imphal East-795003 on the **4th of August, 2023** at around **2 PM**.

That, the criminals illegally entered the premises of the said Apartment, destroying the doors, windows and other per-installed properties of the said 6(six) Flats which is worth about **Rs.15,50,000/- (Rupees Fifteen Lakhs Fifty Thousand)** only.

That, it seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
