

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of New Lambulane 1<sup>st</sup> street Imphal.

That, on the 3/5/, 2023 at 6 PM my above said residence "Owned/Rented" was attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence and premises worth Rupees 322,300/- (Approx.) and they burnt down all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal slogans..

I, therefore, request you to kindly take strong actions against the perpetrators by registering an **FIR/Zero FIR** under relevant sections of Law.
